<u>A \$15.00 fee and examination application are required for each separately numbered examination</u>: Application processing fee is payable by check, money order or credit card. Cash is <u>NOT</u> accepted. Check or money order must be made payable to "Commissioner of Finance" with the examination number and title indicated on the check or money order. The fee may be waived for candidates meeting certain criteria. See application for more details regarding fee waiver. **Read the announcement** <u>carefully</u>; the application processing fee will <u>NOT</u> be refunded to disapproved applicants.

<u>VACANCY</u>: The eligible list established as a result of this examination will be used, when appropriate, to fill vacancies as they occur in all units under the jurisdiction of the Dutchess County Department of Human Resources.

MINIMUM QUALIFICATIONS: On or before March 1, 2025, to be eligible for this examination, applicant must meet the following minimum qualifications:

EITHER: (A) Associate's degree in a Human Service or Health Science field; OR: (B) Graduation for high school or possession of a high school equivalency diploma and two (2) years of full-time paid or volunteer work experience in a substance abuse or a mental health program;

OR: (C) An equivalent combination of education, training and experience between the limits of (A) and (B) above.

Anticipated Eligibility – Age and Educational Requirements:

According to Civil Service Law, section 54 which became effective September 4, 2024, applicants who are within 12 months of meeting the minimum age or attaining the minimum educational requirements following the date of examination, may take the civil service exam, but will be restricted from certification until such a time that the minimum age or educational requirements are met.

NOTE: Unless otherwise specified, part-time experience will be pro-rated towards meeting the full-time experience requirements.

SPECIAL REQUIREMENTS:

- Must obtain a certification as either a Certified Addiction Recovery Coach (CARC), or a Certified Recovery Peer Advocate (CRPA), or a Certified Recovery Peer Advocate-Provisional (CRPA-P) recognized by New York State Office of Alcoholism and Substance Abuse Services (NYS OASAS) within six (6) months of employment.
- 2. Possession of a valid Driver License to operate a motor vehicle in New York State at time of application and to maintain the position.

DUTIES: This is a peer-based service position in which the incumbent has gained knowledge on how to attain and sustain recovery. This position also will serve as the human link between the Department of Mental Health and the people they service throughout the county. The incumbent in this position works with individuals through stabilization and recovery maintenance and will function as a guide to help with decision making and support steps toward recovery. This position will also provide positive support by helping anyone including persons coming home from treatment or the criminal justice system to avoid relapse, build community support for recovery, or work on life goals such as relationships, work, education, etc. Recovery Coaches are unlike licensed addiction counselors in that coaches are nonclinical and do not diagnose or treat addiction or any mental health issues. However, Recovery Coaches may assist the individual to access clinical services, access systems needed to support recovery such as benefits, and health care. Work is performed under the general direction of a higher-level employee. Supervision of others is not a function of this position. Evenings, weekends, and other than normal work hours maybe expected of this position. **EXAMPLES OF WORK (Illustrative** Only): Initiates and develops a recovery plan to help an individual/family in their recovery from substance use or addiction; promotes recovery by removing barriers and obstacles to recovery; serves as a personal guide and mentor for people seeking, or already in recovery; works with a client to find resources for harm reduction, detox, treatment, family support and education, local or online support groups; or help a client create a change plan to recover on their own; establishes rapport with individuals who may be in crisis related to chemical dependency issues; attends court and other system meetings as a support; works with other peers in advocating for themselves to obtain effective services; provides help to individuals in finding ways to stop using (abstinence), or reduce harm associated with addictive behaviors. serves as a point of contact to the community members to orient them to programs and services that address SUD (substance use disorder) and mental health; provides one on one coaching and support to community members with SUD and or mental health issues; responds to referrals from community stakeholders and connect community members to services and programs; provides outreach and support to community residents through phone calls, home and field visits, peer support groups, and community presentations and meetings; maintains client/patient confidentiality and comply with HIPAA regulations; participates in regular clinical supervision and trainings; collects, manages, and maintains patient/client information including intakes, referrals, services provided, and other relevant information and outcomes.

SUBJECT OF EXAMINATION: A test designed to evaluate knowledge, skills and/or abilities in the following areas:

Preparing written material

These questions test for the ability to present information clearly and accurately, and to organize paragraphs logically and comprehensibly. For some questions, you will be given information in two or three sentences followed by four restatements of the information. You must then choose the best version. For other questions, you will be given paragraphs with their sentences out of order. You must then choose, from four suggestions, the best order for the sentences.

Principles and practices of social casework

These questions test for knowledge of the principles and practices used to provide casework services to individuals and/or families of all ages, backgrounds, and circumstances. Questions will test for application of this knowledge in various settings and will include such topics as assessment, monitoring and evaluating services, counseling, referrals, and advocacy.

Working with individuals to promote mental health

These questions test for knowledge of characteristics, causes and treatment methods associated with working with individuals who may have mental, developmental, physical, social and substance abuse disorders and/or disabilities. Questions cover such topics as establishing, maintaining and terminating client relationships; recognizing, interpreting, and responding to individual and group behaviors, as well as crisis situations; and facilitating access to essential services such as financial, housing, medical, educational, legal, vocational, and recreational.

Interviewing

These questions test for knowledge of the principles and practices employed in obtaining information from individuals through structured conversations. These questions require you to apply the principles, practices, and techniques of effective interviewing to hypothetical interviewing situations. Included are questions that present a problem arising from an interviewing situation, and you must choose the most appropriate course of action to take. **Test guide**:

When the examination is prepared and rated by the New York State Department of Civil Service in accordance with Section 23.2 of the Civil Service Law, the administration of this examination, including rating and review, is governed by the provisions of the New York State Civil Service Rules and Regulations.

<u>RETURNED CHECK FEE</u>: A \$20.00 fee will be required for all returned checks. Failure to submit the returned check fee will disqualify you from the exam in which you participated.

<u>FINGERPRINTING</u>: An appointing authority may require a fingerprint supported background investigation before appointment. The candidate may be responsible for paying any associated fees with this service.

<u>MULTIPLE EXAMINATIONS</u>: If you are applying for civil service examinations offered by other government jurisdictions (New York State, another county, city, etc.) that are being held on the same date as this examination, you must make arrangements to take all examinations at one test site. Note: If you have applied for both New York State and Dutchess County examinations, you must take all examinations at the State site. **You are required to complete and return a <u>Cross-Filer Form</u>, available on the Dutchess County website <u>www.dutchessny.gov</u>, to the Dutchess County Department of Human Resources no less than two (2) weeks prior to the examination date**. Failure to provide such information within this time frame may result in disqualification from one or more examinations.

<u>ALTERNATE TEST DATES</u> may be arranged upon review of documented circumstances in accordance with established policy. Such arrangements must be made prior to the exam except for emergency situations or active military service.

<u>RELIGIOUS ACCOMMODATION</u>: – If you cannot take the test on the announced test date (most written exams held on Saturdays) due to a conflict with a religious observance or practice, indicate this on your application. You will be granted an alternate test date, usually during the following week.

<u>SPECIAL ACCOMMODATION</u>: If you require an accommodation or special assistance in taking an exam, indicate this on your application. Documentation will be required.

<u>COLLEGE CREDITS AND/OR DEGREE</u>: Your degree or college credit must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized as an accrediting agency by the U.S. Department of Education/U.S. Secretary of Education. If your degree was awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency. A list of acceptable companies who provide this service can be found on the internet at http://www.cs.ny.gov/jobseeker/degrees.cfm. You must pay the required evaluation fee.

<u>VETERANS</u>: Military personnel who are either in the service at time of examination or who have already been discharged may apply for disabled or non-disabled veterans' credits if they meet established criteria. Candidates who are interested in these additional credits should request an application and information sheet from the Dutchess County Department of Human Resources. Veterans' application forms will also be available on the website and upon request at the examination center. The completed forms and DD-214 (Member 4 Copy) must be received in the office as soon as possible after the examination date or before the eligible list for this examination is established.

<u>CALCULATORS</u>: Unless otherwise notified, candidates are permitted to use quiet, hand-held, solar or battery powered calculators. Devices with typewriter keyboards, spell checkers, personal digital assistants, address books, language translators, dictionaries or any similar devices are prohibited.

<u>ADMISSION TO EXAMINATION</u>: Do not interpret a notice to appear for, or actual participation in the examination to mean that you have been found to meet fully the announced requirements.

Depending on the time available before an examination, *applicants may be admitted to the examination on the basis of statements made on the application or conditionally, without prior review of the application. Such statements may not be reviewed and/or verified until after the examination is held.* At that time, those candidates not meeting the requirements are disqualified. Candidates who are subsequently disqualified after taking the test will NOT be notified of their score.

If you do not receive a notice <u>three days prior</u> to the date of examination informing you whether or not you are to be admitted to the examination, call the Dutchess County Department of Human Resources immediately at 845-486-2169.

<u>CHANGE OF ADDRESS</u>: Notify this office immediately of any change of address. The appropriate change of address form is available on the website, in the Dutchess County Department of Human Resources, and will be available at the examination center.

<u>RESIDENCE PREFERENCE</u>: Pursuant to Section 23.4a of Civil Service Law, preference in appointment from open-competitive lists may be given to candidates who have been residents in a locality or school district in which appointment is to be made for at least 30 days prior to certification of the eligible list. For appointment in some jurisdictions you may be required to become a resident thereof in accordance with law or resolution.

<u>NOTE</u>: In conformance with section 85-a of the Civil Service Law, children of firefighters and police officers killed in the line of duty shall be entitled to receive an additional ten points in a competitive examination for original appointment in the same municipality in which his or her parent has served. If you are qualified to participate in this examination and are a child of a firefighter or police officer killed in the line of duty in this municipality, please inform this office of this matter when you submit your application for examination. A candidate claiming such credit has a minimum of two months from the application deadline to provide the necessary documentation to verify additional credit eligibility. However, no credit may be added after the eligible list has been established.
