<u>A \$25.00 fee and examination application are required for each separately numbered examination</u>: Application processing fee is payable by check, money order or credit card. Cash is <u>NOT</u> accepted. Check or money order must be made payable to "Commissioner of Finance" with the examination number and title indicated on the check or money order. The fee may be waived for candidates meeting certain criteria. See application for more details regarding fee waiver. **Read the announcement <u>carefully</u>; the application processing fee will <u>NOT</u> be refunded to disapproved applicants.** 

<u>VACANCY</u>: The eligible list established as a result of this examination will be used, when appropriate, to fill vacancies as they occur in the City of Beacon Police Department.

MINIMUM QUALIFICATIONS FOR EXAMINATION: On or before June 14, 2025, to be eligible for the promotion examination, employees must meet the promotion qualifications listed below:

Candidates must be permanently employed in the competitive class within New York State for at least five (5) years as a Police Officer of which at least three (3) years was as a permanent competitive class Police Officer in the City of Beacon immediately preceding June 14, 2025.

<u>NOTE</u>: According to Civil Service Law, section 52.10(a) which became effective September 4, 2024, time served provisionally immediately preceding permanent appointment shall count towards meeting the time in title and the employee shall be eligible to take the promotion examination.

#### SPECIAL REQUIREMENTS:

- 1. <u>Citizenship</u>: United States Citizenship is required.
- 2. <u>Driver's License</u>: Possession of a valid New York State driver license is required. (Applications will be accepted from candidates eligible for such license.)
- Any person appointed to this position must complete supervisory training given by the Municipal Police Training Council as required by law before the appointment can become permanent.
- 4. Candidates must have been appointed as a police officer from an eligible list established according to merit and fitness as provided by Section 6 of Article five of the Constitution of the State of New York or must have previously been employed as a Police Officer in an agency under the jurisdiction of the Dutchess County Department of Human Resources.

**DUTIES**: This is responsible work involving the immediate charge of the law enforcement activities of several Police Officers on an assigned shift. The work is carried out in accordance with modern law enforcement practices and general instructions received from officers of higher rank. This class differs from that of Police Officer by virtue of the responsibility to supervise others. Work is performed under general supervision of a higher ranking officer, with some leeway allowed for exercise of judgment in emergencies. General supervision is exercised over Police Officers and other subordinate employees. Incumbent is responsible for the protection of life and property. **EXAMPLES OF WORK (Illustrative Only)**: Inspects each squad or platoon before it goes on duty for compliance with departmental regulations; transmits orders to Police Officers personally or by telephone, radio or computer; checks Police Officers in the performance of duties and makes suggestions for better execution of work; reviews and may approve daily reports submitted by Police Officers and others as necessary; reports any breach of duty or inefficiency; books and inspects prisoners for injuries, issues vouchers for their valuables and ensures that correct charges are placed; takes statements and affidavits from suspects and witnesses; keeps all records of persons arrested, detained or released on bond; maintains order and is in charge of prisoners in court; acts as a detective when assigned; when assigned to a split position, performs the duties of a Police Officer; occasionally takes charge of traffic detail; does related work as required.

**SUBJECT OF EXAMINATION**: A test designed to evaluate knowledge, skills and /or abilities in the following areas:

#### Law enforcement methods and practices

These questions test for knowledge of accepted police methods and practices and/or their application to situations in the police field. The questions are a sampling of the various knowledge that police personnel may be required to possess in the course of their day-to-day work-related activities.

#### New York State Laws - Police

These questions test for knowledge of the laws in effect on January 1, 2025 that law enforcement personnel may encounter in the course of their day-to-day work-related activities. The questions are a sampling of job-related sections of the Penal Law, Criminal Procedure Law, Vehicle and Traffic Law, Family Court Act and other laws relevant to law enforcement in New York State.

## Supervision

These questions test for knowledge of the principles and practices employed in planning, organizing, and controlling the activities of a work unit toward predetermined objectives. The concepts covered, usually in a situational question format, include such topics as assigning and reviewing work; evaluating performance; maintaining work standards; motivating and developing subordinates; implementing procedural change; increasing efficiency; and dealing with problems of absenteeism, morale, and discipline.

## Understanding and interpreting written material

These questions test how well you comprehend written material. You will be provided with brief reading selections and will be asked questions about the selections. All the information required to answer the questions will be presented in the selections; you will not be required to have any special knowledge relating to the subject areas of the selections.

## Preparing written material in a police setting

These questions test for the ability to prepare the types of reports that police personnel write. Some questions test for the ability to present information clearly and accurately. They consist of restatements of information given in note form. You must choose the best version from each set of four choices. Other questions test for the ability to organize paragraphs. They consist of paragraphs with their sentences out of order. For each of the paragraphs you must choose, from four suggestions, the best order of the sentences.

When the examination is prepared and rated by the New York State Department of Civil Service in accordance with Section 23.2 of the Civil Service Law, the administration of this examination, including rating and review, is governed by the provisions of the New York State Civil Service Rules and Regulations.

SENIORITY shall be computed from the date of original permanent appointment in the <u>classified</u> service.

One point for each creditable five-year period up to a maximum of five points as follows:

Less than 1 year-----0 points
Over 11 years up to 16 years-----4 points
Over 6 years up to 11 years up to 11 years up to 21 years-----5 points
Over 21 years up to 26 years-----5

Transfer from service in other government units within New York State shall be included in computing seniority.

### **GENERAL INFORMATION - PROMOTIONS**

The position the promoted individual vacates will only be filled on a temporary basis or contingent permanent basis pending the satisfactory completion of their probationary period. At any time during the probationary period the employee can return to the position that he or she was promoted from.

RETURNED CHECK FEE: A \$20.00 fee will be required for all returned checks. Failure to submit the returned check fee will disqualify you from the exam in which you participated.

<u>FINGERPRINTING</u>: An appointing authority may require a fingerprint supported background investigation before appointment. The candidate may be responsible for paying any associated fees with this service.

<u>MULTIPLE EXAMINATIONS</u>: If you are applying for civil service examinations offered by other government jurisdictions (New York State, another county, city, etc.) that are being held on the same date as this examination, you must make arrangements to take all examinations at one test site. Note: If you have applied for both New York State and Dutchess County examinations, you must take all examinations at the State site. **You are required to complete and return a <u>Cross-Filer Form</u>, available on the Dutchess County website <u>www.dutchessny.gov</u>, to the Dutchess County Department of Human Resources <b>no less than two (2) weeks prior to the examination date**. Failure to provide such information within this time frame may result in disqualification from one or more examinations.

<u>ALTERNATE TEST DATES</u> may be arranged upon review of documented circumstances in accordance with established policy. Such arrangements must be made prior to the exam except for emergency situations or active military service.

<u>RELIGIOUS ACCOMMODATION</u>: – If you cannot take the test on the announced test date (most written exams held on Saturdays) due to a conflict with a religious observance or practice, indicate this on your application. You will be granted an alternate test date, usually during the following week.

SPECIAL ACCOMMODATION: If you require an accommodation or special assistance in taking an exam, indicate this on your application. Documentation will be required.

<u>COLLEGE CREDITS AND/OR DEGREE</u>: Your degree or college credit must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized as an accrediting agency by the U.S. Department of Education/U.S. Secretary of Education. If your degree was awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency. A list of acceptable companies who provide this service can be found on the internet at <a href="http://www.cs.ny.gov/jobseeker/degrees.cfm">http://www.cs.ny.gov/jobseeker/degrees.cfm</a>. You must pay the required evaluation fee.

<u>VETERANS</u>: Military personnel who are either in the service at time of examination or who have already been discharged may apply for disabled or non-disabled veterans' credits if they meet established criteria. Candidates who are interested in these additional credits should request an application and information sheet from the Dutchess County Department of Human Resources. Veterans' application forms will also be available on the website and upon request at the examination center. The completed forms and DD-214 (Member 4 Copy) must be received in the office as soon as possible after the examination date or before the eligible list for this examination is established.

<u>CALCULATORS</u>: Unless otherwise notified, candidates are permitted to use quiet, hand-held, solar or battery powered calculators. Devices with typewriter keyboards, spell checkers, personal digital assistants, address books, language translators, dictionaries or any similar devices are prohibited.

ADMISSION TO EXAMINATION: Do not interpret a notice to appear for, or actual participation in the examination to mean that you have been found to meet fully the announced requirements. Depending on the time available before an examination, applicants may be admitted to the examination on the basis of statements made on the application or conditionally, without prior review of the application. Such statements may not be reviewed and/or verified until after the examination is held. At that time, those candidates not meeting the requirements are disqualified. Candidates who are subsequently disqualified after taking the test will NOT be notified of their score. If you do not receive a notice three days prior to the date of examination informing you whether or not you are to be admitted to the examination, call the Dutchess County Department of Human Resources immediately at 845-486-2169.

<u>CHANGE OF ADDRESS</u>: Notify this office immediately of any change of address. The appropriate change of address form is available on the website, in the Dutchess County Department of Human Resources, and will be available at the examination center.

<u>RESIDENCE PREFERENCE</u>: Pursuant to Section 23.4a of Civil Service Law, preference in appointment from open-competitive lists may be given to candidates who have been residents in a locality or school district in which appointment is to be made for at least 30 days prior to certification of the eligible list. For appointment in some jurisdictions you may be required to become a resident thereof in accordance with law or resolution.

NOTE: In conformance with section 85-a of the Civil Service Law, children of firefighters and police officers killed in the line of duty shall be entitled to receive an additional ten points in a competitive examination for original appointment in the same municipality in which his or her parent has served. If you are qualified to participate in this examination and are a child of a firefighter or police officer killed in the line of duty in this municipality, please inform this office of this matter when you submit your application for examination. A candidate claiming such credit has a minimum of two months from the application deadline to provide the necessary documentation to verify additional credit eligibility. However, no credit may be added after the eligible list has been established.
