## Administration of an exam does not imply a vacancy exists.

A \$15.00 fee and examination application are required for each separately numbered examination: Application processing fee is payable by check, money order or credit card. Cash is **NOT** accepted. Check or money order must be made payable to "Commissioner of Finance" with the examination number and title indicated on the check or money order. The fee may be waived for candidates meeting certain criteria. See application for more details regarding fee waiver. **Read the announcement carefully; the application processing fee will NOT** be refunded to disapproved applicants.

**NOTE**: When applying for both open competitive and promotion or open competitive and interdepartmental promotion examinations for the same title, the examination fee will be waived for the promotion or interdepartmental promotion examination only.

<u>VACANCY</u>: The eligible list established as a result of this examination will be used, when appropriate, to fill vacancies as they occur in all units under the jurisdiction of the Dutchess County Department of Human Resources.

**NOTE**: An Open Competitive examination is being given in conjunction with this Promotion examination. The Promotion eligible list will be certified FIRST.

<u>MINIMUM QUALIFICATIONS FOR EXAMINATION</u>: On or before January 10, 2026, to be eligible for the promotion examination, employees must meet the promotion qualifications listed below:

Candidates must be permanently employed by the County of Dutchess as an Accounting Clerk for a period of one (1) year in the competitive class, or in the non-competitive class under NYS Civil Service Law Section 55-a, immediately preceding January 10, 2026.

#### NOTES

- 1. According to Civil Service Law, section 52.10(a) which became effective September 4, 2024, time served provisionally immediately preceding permanent appointment shall count towards meeting the time in title and the employee shall be eligible to take the promotion examination.
- 2. Unless otherwise specified, part-time experience will be pro-rated towards meeting the full-time experience requirements.

**DUTIES**: This position, while responsible for the processing of transactions associated with one or more financial accounts, has primary responsibility as a supervisor and/or for the assignment of a specialized technical account keeping function which involves independent decision making and accountability. **EXAMPLES OF WORK (Illustrative Only)**: Oversees the preparation, processing, and reporting of specialized account keeping activities such as federal and state claims for reimbursement; researches current accounts, previous reports, source documents, etc., to develop specified information not readily available from current account balances; oversees the collection of information and the completion of state and federal claims for reimbursement; performs detailed research to verify the accuracy of accounts and the adequacy of supporting documents performs financial analysis in such areas as capital project management and budgeting; may supervise lower-level clerical personnel including the distribution and review of work, coverage of all unit activities, and job and performance counseling; works with other departments to resolve problems that relate to financial transactions; functions as the technical resource in programs such as student loans, scholarships, financial aid, and employee benefits; interprets regulations and compiles information for reports for use by professional accounting staff.

#### **SUBJECT OF EXAMINATION**: A test designed to evaluate knowledge, skills and/or abilities in the following areas:

#### Name and number checking

These questions test for the ability to distinguish between sets of words, letters, and/or numbers that are almost exactly alike. Material is usually presented in two or three columns, and you will have to determine how the entry in the first column compares with the entry in the second column and possibly the third. You will be instructed to mark your answers according to a designated code provided in the directions.

### Fundamentals of account keeping and bookkeeping

These questions test for a knowledge of basic principles and practices of account keeping and bookkeeping. The questions test for recognizing account keeping and bookkeeping terms, concepts and relationships; recording financial transactions; and solving elementary problems in account keeping and bookkeeping.

#### Arithmetic computation with calculator

These questions test for the ability to use a calculator to do basic computations. Questions will involve addition, subtraction, multiplication and division. You may also be asked to calculate averages, to use percents, and to round an answer to the nearest whole number. You should bring with you a hand-held battery- or solar-powered calculator for use on this test. You will not be permitted to use the calculator function of your cell phone.

#### Working with office records

ISSUED: 10/29/2025

These questions test your ability to work with office records. The test consists of two or more sets of questions, each set concerning a different problem. Typical record keeping problems might involve the organization or collation of numerical data from several sources; maintaining a record system using running balances; or completion of a table summarizing data using totals, subtotals, averages and percents. You should bring with you a hand-held battery- or solar-powered calculator for use on this test. You will not be permitted to use the calculator function of your cell phone.

When the examination is prepared and rated by the New York State Department of Civil Service in accordance with Section 23.2 of the Civil Service Law, the administration of this examination, including rating and review, is governed by the provisions of the New York State Civil Service Rules and Regulations.

<u>SENIORITY</u> shall be computed from the date of original permanent appointment in the <u>classified</u> service. One point for each creditable five-year period up to a maximum of five points as follows:

Less than 1 year------ 0 points
1 year up to 6 years------1 point
Over 6 years up to 11 years------ 1 point
Over 6 years up to 11 years------- 2 points
Over 21 years up to 26 years------5 points

Transfer from service in other government units within New York State shall be included in computing seniority.

#### $\underline{\textbf{GENERAL INFORMATION}} - \underline{\textbf{INTERDEPARTMENTAL PROMOTIONS}}$

On Interdepartmental Promotion eligible lists, preference will be given to employees in the department where the vacancy exists before eligibles employed in other departments are certified. Any current department promotion lists will be certified before an interdepartmental eligible list is certified. The position the promoted individual vacates will only be filled on a temporary basis or contingent permanent basis pending the satisfactory completion of their probationary period. At any time during the probationary period the employee can return to the position that he or she was promoted from.

RETURNED CHECK FEE: A \$20.00 fee will be required for all returned checks. Failure to submit the returned check fee will disqualify you from the exam in which you participated.

<u>FINGERPRINTING</u>: An appointing authority may require a fingerprint supported background investigation before appointment. The candidate may be responsible for paying any associated fees with this service.

<u>MULTIPLE EXAMINATIONS</u>: If you are applying for civil service examinations offered by other government jurisdictions (New York State, another county, city, etc.) that are being held on the same date as this examination, you must make arrangements to take all examinations at one test site. Note: If you have applied for both New York State and Dutchess County examinations, you must take all examinations at the State site. **You are required to complete and return a <u>Cross-Filer Form</u>, available on the Dutchess County website <u>www.dutchessny.gov</u>, to the Dutchess County Department of Human Resources <b>no less than two (2) weeks prior to the examination date**. Failure to provide such information within this time frame may result in disqualification from one or more examinations.

<u>ALTERNATE TEST DATES</u> may be arranged upon review of documented circumstances in accordance with established policy. Such arrangements must be made prior to the exam except for emergency situations or active military service.

<u>RELIGIOUS ACCOMMODATION</u>: – If you cannot take the test on the announced test date (most written exams held on Saturdays) due to a conflict with a religious observance or practice, indicate this on your application. You will be granted an alternate test date, usually during the following week.

<u>SPECIAL ACCOMMODATION</u>: If you require an accommodation or special assistance in taking an exam, indicate this on your application. Documentation will be required.

COLLEGE CREDITS AND/OR DEGREE: Your degree or college credit must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized as an accrediting agency by the U.S. Department of Education/U.S. Secretary of Education. If your degree was awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency. You must pay the required evaluation fee.

<u>VETERANS</u>: Military personnel who are either in the service at time of examination or who have already been discharged may apply for disabled or non-disabled veterans' credits if they meet established criteria. Candidates who are interested in these additional credits should request an application and information sheet from the Dutchess County Department of Human Resources. Veterans' application forms will also be available on the website and upon request at the examination center. The completed forms and DD-214 (Member 4 Copy) must be received in the office as soon as possible after the examination date or before the eligible list for this examination is established.

<u>CALCULATORS</u>: Unless otherwise notified, candidates are permitted to use quiet, hand-held, solar or battery powered calculators. Devices with typewriter keyboards, spell checkers, personal digital assistants, address books, language translators, dictionaries or any similar devices are prohibited.

ADMISSION TO EXAMINATION: Do not interpret a notice to appear for, or actual participation in the examination to mean that you have been found to meet fully the announced requirements. Depending on the time available before an examination, applicants may be admitted to the examination on the basis of statements made on the application or conditionally, without prior review of the application. Such statements may not be reviewed and/or verified until after the examination is held. At that time, those candidates not meeting the requirements are disqualified. Candidates who are subsequently disqualified after taking the test will NOT be notified of their score. If you do not receive a notice three days prior to the date of examination informing you whether or not you are to be admitted to the examination, call the Dutchess County Department of Human Resources immediately at 845-486-2169.

<u>CHANGE OF ADDRESS</u>: Notify this office immediately of any change of address. The appropriate change of address form is available on the website, in the Dutchess County Department of Human Resources, and will be available at the examination center.

<u>RESIDENCE PREFERENCE</u>: Pursuant to Section 23.4a of Civil Service Law, preference in appointment from open-competitive lists may be given to candidates who have been residents in a locality or school district in which appointment is to be made for at least 30 days prior to certification of the eligible list. For appointment in some jurisdictions you may be required to become a resident thereof in accordance with law or resolution.

NOTE: In conformance with section 85-a of the Civil Service Law, children of firefighters and police officers killed in the line of duty shall be entitled to receive an additional ten points in a competitive examination for original appointment in the same municipality in which his or her parent has served. If you are qualified to participate in this examination and are a child of a firefighter or police officer killed in the line of duty in this municipality, please inform this office of this matter when you submit your application for examination. A candidate claiming such credit has a minimum of two months from the application deadline to provide the necessary documentation to verify additional credit eligibility. However, no credit may be added after the eligible list has been established.
